COOKIES POLICY

This document provides information about the storage of information and obtaining access to the information already stored on the terminal of the user or visitor to the website <u>www.libreriadeorgasmos.com</u> (henceforth the Website), in accordance with Law 34/2002, of 11 July, regarding services of the information society and electronic commerce, updated with the application of the General Data Protection Regulation on May 25th 2018.

The data storage and retrieval devices in the recipients' terminals (cookies) are small archives or texts, often encoded, that a web server stores/records in users' or visitors' equipment or devices when they access a website or page. Such cookies can store information about the equipment or browsing session used to visit the website or page, the places that are browsed and the browsing preferences. When the website or page is revisited, the cookies are read to facilitate browsing and establish or restore the browsing preferences and configuration of the user or visitor. If cookies are not enabled certain services or functionalities of the website will not be available to the user.

Devices for storing and recovering data: This website uses the following cookies:

Possible processing of personal data: The possible data of a personal nature gathered for the use of cookies, or the possible identification of natural persons through the use of cookies, depending on the services used or accessed in the website or page, and the configuration the users maintain on their terminals, will be processed by BIJOUX INDISCRETS S.L., Viladomat 291 6°2ª, 08029 - Barcelona, Spain, as the entity responsible for the processing, to facilitate and improve the browsing experience on the website and to analyse visits. In the event of other entities using cookies through this website, such entities shall be responsible for the data of a personal nature that may be processed, being identifiable by the cookie URL. If you accept the cookies, browsing or visiting this website or page, without rejecting or deleting the cookies, you consent to the possible processing of your data of a personal nature for all the purposes indicated.
